The Committee would like to make the following recommendations:

1. The Nominating Committee Chair should receive a copy of the Chapter Bylaws section(s) that deal with nominations if there is not a current copy available. Until the 1990 Membership Directory was published (which includes the Bylaws), there was not a current copy of the Bylaws except the various revised sections that have appeared in the newsletters. It should be stated that the election ballots are sent from the Secretary, not the Nominating Committee.

2. A biographical form be used so that each candidate nominated for an office is giving the same types of information and in the same format. This will eliminate differing amounts of information and it will enable the information to be reproduced in the newsletter and on the ballots in a more timely manner. Attached is a sample form for the Executive Committee's review.

3. A master list of prior officers be given to the Nominating Committee Chair so that one does not nominate someone who has served in the same office in the past. This would not preclude someone from serving in another office. This is especially helpful for some members of the Committee who may not know who has served in the past.
