1957 SECAALL Meeting\*\*\*Atlanta, Georgia\*\*\*August 22-24, 1957

Dear Law Librarian:

The 1957 Convention program for the Southeastern Chapter, American Ass'n of Law Libraries, meeting in Atlanta, August 22-24 was mailed out May 20. The Local Arrangements Committee had planned originally to have the meeting the last week of August, but the Shrine Convention, some ten thousand strong, will descend on Atlanta that weekend, and every hotel room in the city has been spoken for. We regret, therefore, that we must forego the original date of August 29. However, excellent accommodations for the week of August 22 are available at the Georgian Terrace Hotel. Stimulating intellectual and recreational activities have been arranged, including speakers, barbecue, and the banquet.

The banquet will present a departure from the usual in our program. The Harrison Law Book Company will be the host at a reception and banquet for the attending law librarians. Due to the vacation plans of the host publisher, the banquet will be held the first evening of the meeting, Thursday, August 22, we therefore urge all members who will attend to arrive early Thursday afternoon. This will give you time for registration and an opportunity to freshen-up for the evening festivities. These changes will be noted in our program that has gone to the membership, and as we know that we can't hope to compete with the "Squaw dress" plans of the National Convention, we believe we can offer you the entire resources of Atlanta, which are considerable according to the local convention bureau, and promise you an enjoyable weekend.
