In 1957 the Southeastern Chapter held its annual meeting in Atlanta on August 22-24. Miss Corinne Bass, President, presiding over the thirteen members in attendance. The Georgia State Library and Emory University Law Library were hosts to the group.

Chapter members present were: Mary Oliver, Minnette Massey, Stanley Bougas, Corinne Bass, Dorothy Salmon, Caroline Heriot, Francis McCoy, John Folger, Vera Jameson, Sara Leverette, Madge Tomony, Ruth Corry, Margaret Prendergast.

Among the guests were Mrs. Phillip Bryant of the Georgia Department of Archives and History. The Chapter was also honored by the presence of another distinguished guest, the 1958 President of AALL, Miss Helen Hargrave of the University of Texas who attended the Chapter meeting on an official visit. Miss Hargrave described some of the problems and general plans of AALL in 1958.

The Atlanta meeting started with a banquet Thursday night at the East Lake Country Club given by Mr. John Elliott of the Harrison Company. Guests for the occasion included Dr. and Mrs. Tom Green (Jane Oliver). The latter was the Chapter's 1954 President. Justice Bond Almond of the Supreme Court and Miss Carroll Hart, Assistant Archivist of Georgia along with Mr. Elliott comprised the banquet speakers.

On Friday's program Miss Mary Oliver and a panel of Librarians from Emory University discussed Law Library Recruitment Problems. Another portion of the program, The Public Relations Aspect of Library Work was analyzed by Miss Eunice Coston of the Atlanta Public Library. The third major topic on the program was Legal Bibliography as Taught and Practiced. This subject was examined by Dorothy Salmon and Sara Leverette. The Luncheon speaker was Dean Hepburn of the Emory University Law School.

At the business meeting held Saturday morning Stanley Bougas of Emory University was appointed editor of the Chapter Newsletter and the Chapter files were deposited with Ruth Corry of the Georgia State Library in Atlanta.

During the year the Chapter Newsletter was edited by Stanley Bougas of Emory University. It contained a list of practice books for Kentucky and Louisiana. The states of Alabama, Georgia and North Carolina having already been included in a previous Newsletter.

It was decided that the Southeastern Chapter would not meet with the Southeastern Law Teachers in 1958 but that the next

meeting of the chapter would be held in Washington on Sunday, June 29, one day prior to the 1958 meeting of AALL.
