The Southeastern Regional Conference of Law Teachers will meet on August 24, 25, 26, 1969 at the Royal Orleans Hotel, New Orleans. We will hold our Chapter Meeting in conjunction with this group and a one-day session for our Chapter is being planned. If you have a topic that you would like to have considered and discussed, let our President Sarah Leverette know today. Plans for this meeting are in the making now! This is a Regional meeting and normally the group is small. Sometimes, the smaller the group the more worthwhile the meeting! This meeting at New Orleans will give you an opportunity to "talk over" your problems with Librarians from Law Schools, Bar Librarians, and Firm Librarians. The weather may be hot in New Orleans in August, but the air-conditioned hotel will make for "good-living".

In November, 1968, we received the letter from Gerard Magavero (Univ. of Miss.) concerning the checking of the A.A.L.S. Law Books Recommended for Libraries. I know some of us have started checking our shelf-list with the A.A.L.S. list. It is a slow and tedious "job". Mr. Magavero suggests that if you can take time out from your busy schedule, he would appreciate hearing from you and advising him about your checking. The checking of the A.A.L.S. list certainly proves more meaningful to us in the Law Schools with small budgets because of the recent Amendment of Articles of the Association of American Law Schools concerning our libraries. By 1975 we must have 60,000 volumes and a total annual expenditure of \$40,000 for new acquisitions must be considered as a minimum for the school during 1968-71.
