As to Leah's suggestion about county nominee for Secretary-Treasurer, I think it is a good idea if we can locate someone who has been active and attended some of the A.A.L.L. and S.E. meetings. In checking over Bill Younger's lists of attending members of the A.A.L.L. and S.E. Chapter meetings for the past several years (see attached), I can only locate one county law library member who has attended any of these meetings; (Miss Margaret Prendergast, Mobile County Law Library attended 1969 S.E. Chapter Meeting in New Orleans.)

I do not think this lack of attendance of county law librarians reflect lack of interest, but rather lack of trainee grants given them to attend. If I am correct, then, it may be unrealistic to think that a county law librarian would have enough staff to do the necessary work involved in being Secretary-Treasurer. Miss Pillau, please give us the benefit of your observations and suggestions about this.

I would suggest that we seriously consider two law school librarians who faithfully attend both A.A.L.L. and S.E. meetings.

Miss Anna Johnson, William and Mary, Walton Garrett, Memphis State University, both have also been active on various committees. I do consider that being elected an officer in S.E. should be considered as an honor based upon recognition of past service; and not a speculative venture of motivating new and future service.
