## **Proposed SEAALL Bylaws Amendment**

Below is a proposed change to the SEAALL bylaws that will be included on the March 29 election ballot.

#### **Proposed Bylaws Change**

**Goal**: To amend Article VII Nominations and Elections, Section 1., Subsection A., Nominating Committee to require a member of the Diversity & Inclusion Committee to be part of the Nominating Committee.

Below is a red-line version of how this section of the Bylaws would change if enacted:

#### **Article VII Nominations and Elections**

#### **Section 1. Nominations**

#### A. Nominating Committee

The Executive Board shall appoint a Nominating Committee who shall submit the names of the candidate or candidates for each of the following offices by December 1 of the fiscal year in which the election is to be held: Vice President/President-Elect, Secretary, Treasurer. The composition of the Nominating Committee is at the discretion of the SEAALL President, but the committee must include at least one member of the Diversity & Inclusion Committee.
