Tech Tip: “Let’s talk tech...”

You’ve probably noticed every where you turn, technology is under discussion. Advertisements for classroom technology, law firm technology, and personal connectivity and productivity fill

your inbox. Vendors call offering software and database trials. Who is using all this legal technology? How are people learning to use legal technology? Bloomberg Law recently published two surveys which overlap in an interesting way for legal education.

The first survey is Bloomberg Law’s [2021 Law School Preparedness Survey](#). BL surveyed more than 1000 practicing attorneys, law students, law faculty, and law librarians. A few statistics from this survey are revealing about the role of technology and which skills are expected. The primary skill for new attorneys expected by 80% of respondents is familiarity with “client communications and interactions.” While communications might seem like a soft skill, consider how effective communications, even virtually, can make stressful times for clients more bearable or enhance virtual collaboration. A second statistic I found interesting was which research resources are being used. Seventy-one percent of attorneys

used regulations and agency documents as opposed to 47% of law students. Seventy-one percent (again) of attorneys used practice guides, forms, and checklists for research as opposed to 40 % of students. The preparedness survey shows us practical skills are expected and legal technology only adds to the mix for new attorneys. We can ask if these skills are taught in a manner that matches employers’ expectations.

The second recent Bloomberg survey is the [Legal Technology Survey 2021](#). BL surveyed 202 law firm and legal organization employees about the use, impact, and evaluation of legal tech at their organization. One statistic jumped out at me from the top-line results of the survey. Over 90% of respondents rate their organization’s daily use of legal technology at a “5” or more on a scale from 0-10. Clearly, legal tech is embedded in legal organizations and adoption will only increase.

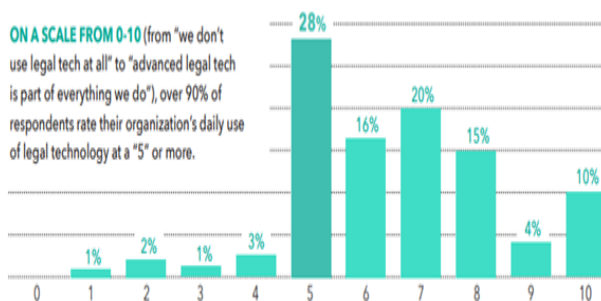
A second take-away from the Bloomberg Legal Technology Survey was the reported barriers to legal technology use. The top barrier reported at 51% is “lack of tech-savvy users.” Almost 50% reported “lack of familiarity with available tech” as the second-highest barrier. Coming in at third place at over 40% is “lack of time to learn the tech.” These reported barrier responses may not be surprising to you, but it does raise the question are firms using their legal technology effectively? How are attorneys learning to use their technology? What are the ability expectations for incoming law clerks, judicial clerks, or new associates?

These two surveys raise provoking questions for legal education. At what point in legal education is technology introduced and taught? Do legal organizations expect new associates to inherently have these skills or is there some in-house training, either by the law librarian, vendors, or continuing legal education/certification programs? If legal technology is introduced or offered in law schools, who is teaching, in

which classes, and what topics are covered? If you attended SEAALL’s annual meeting, legal technology education was addressed in at least two presentations: “So You Want to Teach Law Practice Technology?” and “Do Law Schools Have an Ethical Obligation to Provide Skills-based Legal Technology Instruction?” (Be sure to look for the special SEAALL newsletter annual meeting review issue for recording links).

Integration of Legal Technology into Daily Operations

ON A SCALE FROM 0-10 (from “we don’t use legal tech at all” to “advanced legal tech is part of everything we do”), over 90% of respondents rate their organization’s daily use of legal technology at a “5” or more.



Bloomberg Law surveyed 202 law firm and legal organization employees in August 2021 about legal technology – including the use, impact, and evaluation of legal tech at their organization, as well as their thoughts on efficiency, well-being, and spend. This report highlights the top-line results from the survey.

So, back to “Let’s Talk Tech.” Maybe you are teaching technology skills now, one-on-one or in a technology class. Maybe you’ve noticed some gaps in your law students’, law clerks’, or associates’ skills. We know the need and employment market for skilled technology users will only increase. We have survey results and SEAALL presentation concepts to in-

form a wider discussion about legal technology education on campus or in your office. If new attorneys would benefit from practical skills and technology training, it is probably time to “talk tech” and have a larger conversation with your legal research and writing professors and legal organization management.

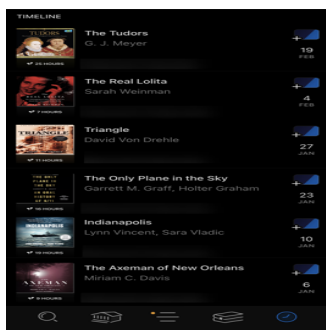

than I ever could, but let me tell you what, I did learn a lot.

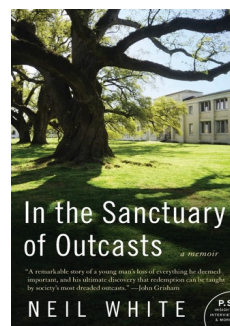

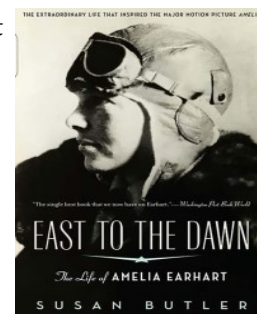

have been read because they remind me of highlights in life.

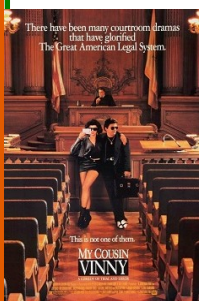
Now my job as a cataloger makes me somewhat ashamed to admit that it’s like the Wild West on my personal bookshelves.

Legal Movie Review: *My Cousin Vinny* (1992)

To find a legal movie to review, I used my advanced-level search techniques and Googled various phrases: favorite legal movies, movies for law students, best legal movies ever. And while many on those lists are great movies, nothing jumped out at me. As an experienced researcher, I then tried the next best option: browsing my law library's collection of DVDs. After many minutes of pacing back and forth, our circulation librarian, Bill, in his ever-helpful way, asked if he could help me find something. Running out of search ideas, I asked him to name his favorite legal movie. Without hesitation, he said, "My Cousin Vinny," and he pulled it right off the shelf.

I was skeptical...there had to be a reason I haven't watched it since its release 30 years ago. Looking at the DVD cover, I found that reason – Joe Pesci has the lead role, and I'm not a big fan of his. As I was pondering whether to watch it, Bill told me that an evidence professor shows it to her class. Now I am curious.



Pesci plays an attorney, recently admitted to the New York Bar after his sixth attempt, who travels to Alabama to defend his cousin and college friend against murder charges. Pesci hasn't appeared in court before, and he struggles with courtroom procedures, like how to properly address the judge and how to dress appropriately. The judge, played by Fred Gwynne



(more commonly known to me as Herman in "The Munsters" sitcom from the 1960s),



loses patience with Pesci and jails him for contempt several times. Pesci's fiancée, played by Marisa Tomei, saves the day, over and over and over again. Not only does Tomei bail him out of jail, she explains the discovery rules to him, and in true girl-saves-boy fashion, she saves his case during the trial.

The criminal charges stem from the murder of a salesclerk at the convenience store where the defendants had stopped. The case appears hopeless as the district attorney parades several eyewitnesses to the stand to testify that the defendants' car was *the car* squealing away from the store. On cross,

Pesci does a decent job casting doubt on the eyewitnesses' credibility, but by now, any resemblance to a real-life trial has been tossed aside. And it only gets more far-fetched when Pesci presents the defendants' side of the case.

At the outset of the movie, Tomei is portrayed as Pesci's traveling sidekick, taking scores of pictures to commemorate her trip to the South. As luck would have it, she took a picture of a car's skid marks outside of the convenience store; and even luckier, the pictures were developed shortly before Pesci calls his first witness, who turns out to be – you guessed it – Tomei. After the district attorney satisfies himself that Tomei is, in fact, a scientific expert because she worked in her father's car repair shop, she pontificates, with minimal questioning by Pesci, about all things related to cars and tires.

It's worth noting that Tomei won an Oscar for Best Supporting Actress for this role, and I attribute much of that success to her "scientific testimony." Juries everywhere would have found for the defendants in a heartbeat. With that said, however, I'll surmise that our professor doesn't find this testimony nearly as compelling.

So, is this now my favorite legal movie? Probably not, but it frequently had me "laughing out loud," despite (or because of, I'm not sure) its stereotypical scenes and characters, foul language, and slapstick comedy. Would I watch it again? Absolutely...because in today's world where there's not much to laugh about, a good old-fashioned belly laugh is a welcomed respite.

Take a moment to reflect on your journey to law librarianship. Is there a person or people who stand out in your memory because of the advice or guidance they provided? For most of us, a name or a face quickly comes to mind, followed by a smile or a fond memory. However, for too many people, a reflection of their journey into law librarianship, or librarianship in general, is spotted with periods of sadness and isolation.

As I began writing this article, I wondered what have I experienced in library school that will be of interest to law librarians. Is there a recent technology that I can share? I just could not find that one topic that seemed relevant. Then, I thought about my journey to this moment, only a few classes away from graduation and preparing for a career in librarianship. The word came to me...“mentor.” From the moment that I entered new student orientation until today, I have been blessed to have people on this journey with me, encouraging me and guiding me. What makes this experience so special is that the relationships have been organic. There was an upcoming conference, and one person thought that I would be interested. There was a scholarship available, and another person thought that I should apply. A third person knew a Spectrum Scholar from a previous year and made introductions. Mentors are a key factor in the growth of the profession of law librarianship. Let's be proactive.

If there is a library school in your area, contact the program's administrative office and offer to speak at an upcoming event or to a small group of students regarding law librarianship. Most likely, the various student organizations will be hosting a speaker event and would appreciate your participation. If you are not near a library school, contact your alma mater and offer to participate in a Zoom event.

Hosting a student, who is pursuing a practicum or a fellowship, is an important way to mentor a future law librarian. In the fall of 2021, I completed a fellowship in a law school library. This opportunity allowed me to see the day-to-day responsibilities of librarians. I was able to work on projects and to ask questions about the profession. In addition to learning practical skills, I formed meaningful relationships with law librarians who now serve as professional references. Working in a law library provided greater insight on courses that I should take. One component of the fellowship was to observe advanced legal research classes. I learned about the teaching aspect of academic law librarianship. This experience inspired me to take a user instruction course in my library program. Through the user instruction course, I am learning effective ways to share course material with students who have diverse learning styles.

In addition to my fellowship, I completed a virtual practicum with an academic library in the summer of 2021. “Experiential

education is critical not only for student satisfaction and enrichment but also for what employers expect from new librarians” (Dixon, 2018, p. 33). In addition, practicums provide an opportunity for graduates to “pair[] experiential learning with coursework, drawing connections between theory and practice” (Dixon, 2018, p. 33). During my practicum, I created a LibGuide regarding distance learning resources and linked one of the LibGuide pages to a mock, Contemporary Art class on the learning management site, which included modules, an assignment, and a quiz. In addition, during my practicum, I observed librarian interviews, spoke with librarians in various positions, attended research assistant workshops, and learned how to make LibGuides more accessible. These experiences are invaluable. Consider mentoring a future law librarian.

The first book on my list, that I will start once I finish *The Ninth*

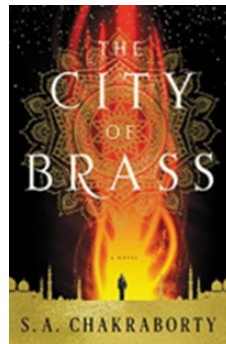

Recent Acquisitions (Guest Author: Adam Harness)

I have been involved in a lot of recent acquisitions over the last year. I acquired a new cat, a new car, a new job, a new apartment, new furniture, and a new adventure in a new state. My library recently acquired a fabulous new law librarian, new books, a new library space (hopefully completed soon), and some new electronic resources. While I am tempted to talk at length about our new, amazing law librarian (aka me), I believe that would be just a little too egocentric. Instead, I am going to discuss one of the resources we have recently acquired for the Charleston School of Law, a research tool called PowerNotes.



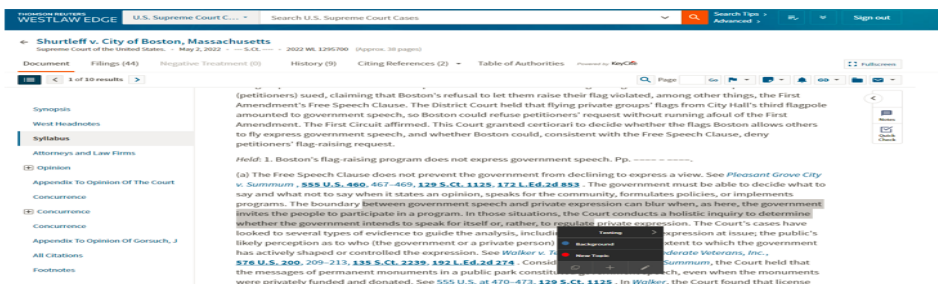
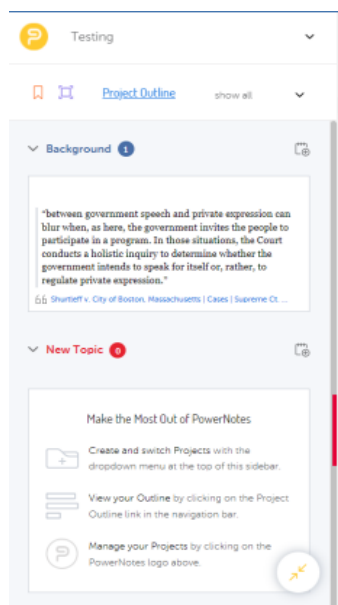
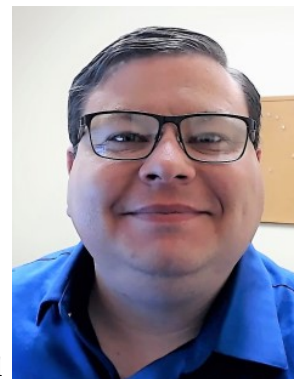
For those of you that have yet to discover this gem, PowerNotes is an online research tool originally designed for law schools to help facilitate legal research in electronic environments. It is a very useful tool for anyone that is researching any topic using electronic media and databases. The best part is that PowerNotes is very user-friendly with lots of powerful features designed to make your research more efficient while also pushing more traffic to your library resources and away from third-party databases. Searching on Google? PowerNotes ties directly into your library's databases and will show your patrons resources through your

library that meet their search criteria.

PowerNotes is entirely web-based. That means that all your notes and outlines follow you everywhere, regardless of what computer you use. All you need is an internet connection. PowerNotes works directly in your internet browser via a browser extension. Simply go to PowerNotes.com, set up an account, and install the browser extension. What happens next depends on your writing style. If you're like me, you'll set up a rudimentary outline before you start researching. PowerNotes will let you do that from either the browser extension or the website. However, if you're like my wife, you'll just want to start researching. PowerNotes will accommodate that style as well, and when

you're ready to set up an outline, you can move the sources and notes you've gathered around to create and fill in your outline.

Using PowerNotes is simple and easy. Once the extension is installed, all you need to do is highlight the parts of the online document that are important or click on the bookmark icon on the browser extension. After you highlight the relevant parts, PowerNotes will ask where you want to save your highlights via a pop-up menu. This menu will show all your outline headings under the current project you are researching. If you want to save the entire page, click on the bookmark button and PowerNotes will save the entire website as a web link on your outline under "Bookmarks." That way you can get save those websites you want to read in more detail without adding them to your favorites, then trying to remember where you put the pesky link, etc. Best of all, PowerNotes works directly with Lexis, Westlaw, and HeinOnline and automatically saves the Bluebook citation provided by those services to any highlights you save from those services.

But Adam, what if I want to research another project?" I'm glad you asked. This is just as simple as everything else. When you need to change projects, simply click on the PowerNotes icon on your screen to open the extension; then click on the project name at the top. This will reveal a pull-down menu that lists all your current projects. Choose the project you are researching, and PowerNotes will do the rest.

PowerNotes website allows you to reorganize your projects, create new projects, and even print your outlines or

export them to Microsoft Word as an annotated bibliography. Using the notes feature, you can even write your paper directly in PowerNotes and then export the entire outline plus notes to Word. All you have to do is fluff it out.

PowerNotes has three membership options: free, premium, and institutional. Their institutional package starts at \$4,200 but is based on your FTE. Institutional accounts have unlimited premium accounts so every staff member, faculty member, and student can have their own premium account and gain all the advanced research tools,

such as the library integration and student accountability functions so professors can check their students' sources. Institutional users sign-up with their institutional email address, and they are good to go. If institutional accounts are a little out of your price range, individual premium accounts start at \$4.99 per month or \$49.99 per year. These accounts do not have all the institutional tools but are still a great way for students and faculty to organize their research projects. Free packages are very basic but does provide some insight into how the product works.

If you are interested in learning more about PowerNotes for your institution, contact PowerNotes to set up a free trial. I don't think you will be disappointed.

The Whiteness of Wealth: How the Tax System Impoverishes Black Americans – And How We Can Fix It

Dorothy A. Brown. Crown Publishing Group, 2021. \$27.00

Since 2020, there has been increased media coverage and more discussion of the racial wealth gap in America: as of 2021, the average Black household earns about half as much as the average White household and owns less than 20 percent as much net wealth. Presidential candidates proposed plans to close the gap, by means such as expanding homeownership among Black Americans and canceling student loan debt.

What received short shrift in

these plans and discussions is the impact of tax policy in causing and sustaining the racial wealth gap. Professor Dorothy A. Brown, a professor in tax policy at Emory Law, tackles this field in her 2021 book, *The Whiteness of Wealth*.

We may think of tax policy as being race-neutral, but this book is an eye-opening look at how wrong that is.

Professor Brown shows how decades of tax policies, from marital tax breaks for one-earner families to lower tax rates on investments such as real estate and stocks, have benefitted White (and especially wealthy and middle-class White) households and penalized the typical Black household, whether intended by specific racial animus or not.

The solutions she proposes are innovative and intriguing. However, at this moment in the political and cultural discourse,

However, at this moment in the political and cultural discourse, where state legislatures in our region are busy passing laws aimed at removing discussion of concepts such as

systemic racism from public schools and universities, it is hard to believe that they could be implemented soon.

The Whiteness of Wealth is very engaging and readable, either for an academic or a general audience. Her use of narrative showing how tax policy impacts real people and families is relatable and understandable even for those of us who managed to avoid any tax law classes in law school. I highly recommend this book for any academic law library and think it would make terrific supplemental reading in tax law classes where the teacher wants to incorporate more of a social and historical context around tax law and policy.
