As you know we are on an amended schedule for sending application forms, reviewing applications and completing our work.

You will need to set aside time in December to review and score the applications using the individual score sheets.

I propose the following schedule:

Sue will write for the next newsletter an article about the scholarship which will include the application form.

I will receive from Pam early next week the set of labels and will mail to the membership a letter and a copy of the application form stating that the deadline for submission of applications is December 13, 1993. I will Fed-X copies of the applications and the forms to you for your immediate review.

Each of you should return the scoresheets to me by December 22, 1993. You may fax or call me to report your scores. (I will not be in the office December 18-22. If you call, please report your scores to my secretary.)

I will tally your votes. If the results are not conclusive, I will call you during the December break to coordinate the selection process. If possible, recipients will be notified by me during the first week of January.

Following the selection process I suggest that we review the forms in light of our recent experience. I suggest further that we develop a brief proposed schedule for the next committee.

I hope this schedule meets with your approval.
