
Thanks very much for your kind letter of August 15 inviting the Southeastern Chapter of the American Association of Law Libraries to meet in Puerto Rico. This sounds like a good idea, but I do not know whether we could arrange it.

The Southeastern Chapter, A.A.L.L. holds two regular meetings each year. One meeting is held in connection with the annual meeting of the American Association of Law Libraries. That usually is in the latter part of June or around the first of July. Our second meeting is held in connection with the Southeastern Law Teachers Conference. This meeting is usually held around the 20th of August.

My suggestion would be for you to have one of your large law libraries there in Puerto Rico to invite both of these groups to meet in Puerto Rico. Enclosed are copies of pages 43 and 44 of the A.A.L.L. Directory of Law Libraries showing your law libraries and their personnel. These would be the people who would have to invite the A.A.L.L. to meet there.

I understand that Dean Joshua M. Morse, III of Florida State University, Tallahassee, Florida 32306, is the present chairman of the Southeastern Law Teachers Conference. He would probably be the one to contact concerning an invitation for the Southeastern Law Teachers Conference to meet in Puerto Rico. I do not know whether the University of Puerto Rico Law School is a member of the Southeastern Law Teachers Conference. You might ask their dean about this.
