## EDITORIAL

The purpose of this editorial is to offer a suggestion, namely, that the State Bar Association consider the adoption of this journal as its official publication. The Kentucky Law Journal

is the only publication of its kind in the state. It is given over to the discussion of legal problems concerning both general law and the law of Kentucky. Local cases are commented upon and their holdings compared with those found in other jurisdictions. Articles and comments by lawyers and judges of this state are published frequently. Sometime soon there will appear the Kentucky annotations to the Restatement of Contracts, which is in preparation by one of the members of the law college faculty.

The journal reaches a large number of the lawyers of this state. Most of these subscribers are members of the State Bar Association, an organization that has advanced by giant strides within the past five years. This organization needs some official publication, some medium through which members may reach each other. The Kentucky Law Journal should be the logical choice. The students and faculty of the law college at the University of Kentucky have long wished that the State Bar Association might make this move. A number of such associations in other states have done this. It is hoped that Kentucky will follow suit.
