To enable broadest dissemination of the Article, you, acting on behalf of all authors (the "Author") and the Journal agree as follows:

## 1. Acceptance for Publication

#### 2. License to the Journal

The Author retains the copyright and grants to the Journal the worldwide, irrevocable, non-exclusive, and royalty-free rights as follows:

- 2.1 The Journal may publish, reproduce, distribute, display, transmit, archive, and preserve the Article or portions thereof in any manner and in any format through any medium now in existence or developed in the future.
- 2.2 The Journal may prepare translations and abstracts and other adaptations or derivatives of the Article.
- 2.3 The Journal may use the Author's name, likeness, and institutional affiliation in connection with any use of the Article and in promoting the Article or the Journal.
- 2.4 The Journal may authorize third-party entities to include the Article and its bibliographic information in academic databases and discovery services.
- 2.5 The Journal may without further permission from the Author transfer, assign, or sublicense the rights that the Journal has pursuant to this Agreement.
- 2.6 The Journal may publish the Article with a Creative Commons Attribution 4.0 International license (CC BY 4.0) in order to maximize the dissemination. - 2.7 This license of rights to the Journal takes effect immediately. In the event that the Journal does not publish the Article, this license will terminate upon written notification by the Journal to the Author. To the extent that moral rights may apply to the Article, this Agreement does not affect the Author's moral rights in the Article.

## 3. Rights of the Author

The Author is entitled to the following rights:

- 3.1 The Author as the copyright holder may reuse, distribute, or re-publish the Article in any format after its publication in the Journal.
- 3.2 In the event that the published Article includes edits and other contributions by the staff of the Journal, the Author has the right to use such edits and contributions.

#### 4. Responsibility of the Author

In the event that the Article is re-published in any format, the Author agrees to acknowledge its first publication in the Journal by providing the Article's bibliographic information and digital object identifier (DOI) in the re-published version.

### 5. Representations of the Author

The Author represents and warrants the following:

- 5.1 You must be the author, or the authorized agent of the author(s); if the Article has more than one author, the Author by submitting this form represents that s/he has the authority to act on behalf of all other authors and will inform the other authors of the terms of this Agreement;
- 5.2 the author owns the copyright to the Article and has full power to enter into this Agreement and to convey the rights herein granted;
- 5.3 the author(s) must have approved the work for publication;
- 5.4 the author(s) must have agreed to submit the Article to the Journal;
- 5.5 the author(s) must accept full responsibility for the content of the Article;
- 5.6 the Article must be the author(s)' original work, does not violate any existing copyright, is free from all liens and claims and does not defame, invade the privacy of, violate the civil rights of, or infringe upon the rights of any individuals or third parties;
- 5.7 the Article must not have been previously published, is not pending review elsewhere, and will not be submitted for review elsewhere pending completion of the editorial decision process of the Journal.
- 5.8 the Author agrees to indemnify and hold the Journal harmless from any breach of the aforementioned representations.

This Agreement reflects the entire understanding between the Journal and the Author. It may be amended only in writing by an addendum signed by both parties.
